PUBLIC COMMENT

The purpose of this item is twofold. First, to allow any person an opportunity to address the Board Many non-agenda issues regarding daily operational or administrative matters may be quickly and efficiently handled by contacting the City Administration at City Hall by phone. (Texas law prohibits the Board, when meeting in numbers constituting a quorum, from deliberating upon any matter not posed on the agenda in compliance with the Texas Open Meetings Act for that meeting.)

Second, this item is to allow any person an opportunity to address the Board only on matters which *are posted on the agenda prior to any action being taken on the item*, as required by Texas Government Code section 551.007.

Each person providing public comment must sign up prior to the posted start time of the meeting and will be limited to three (3) minutes. The presiding officer maintains the sole discretion to increase or decrease the amount of time provided for public comment as necessary to preside over an effective and efficient meeting but will not apply any limitations based on the views expressed by the speaker.

Action, if any, will be taken in open session.
